## Policy 3.5 - Delegate/Proxy

- 1. <u>Purpose</u> It is recognized that attendance at all meetings may be difficult for PCOs and Executive Committee Officers (ECOs). This policy provides options that will allow the PCO and ECO to submit a designated replacement at the Central Committee meeting(s) or Executive Committee meeting(s) to ensure sufficient representation during committee business. It is the duty of the PCO or ECO to submit the delegate/proxy candidate as follows:
  - 1.1. Delegates or proxies are not allowed at the Organization Meeting.
  - 1.2. A Delegate/Proxy for a PCO must be a declared Republican and a registered voter *in the same precinct*.
  - 1.3. A Delegate/Proxy for an ECO must be a declare Republican and a registered voter in Benton County, WA.
  - 1.4. The BCRP Chair's automatic delegate/proxy is the BCRP Vice-Chair in accordance with §5.2.2 of the BCRP By-Laws.
  - 1.5. Under no circumstances can a person cast more than one vote on any item.
  - 1.6. All delegates or proxies shall be in writing by the maker and delivered to the Credentials Chair via electronic transmittal, mail, or in person
    - 1.6.1. The Credentials Chair shall verify the Delegate/Proxy's credentials at CENTRAL COMMITTEE MEETINGS
    - 1.6.2. The **Secretary** shall verify the delegate or proxy's standing at EXECUTIVE COMMITTEE MEETINGS.
  - 1.7. Delegate/Proxy designation provided at least 24 hours in advance of the meeting will be accepted.
  - 1.8. Standing delegates/proxies are permitted.
  - 1.9. Delegates/Proxies shall sign in with the Credentials Committee under the PCO or ECO that they are representing.
